1. Introduction

Welcome to the Jms Multi Sites' world.

This user manual describes the “Multisites Custom HTML” that is a module that allow sharing “Custom HTML” between different websites defined under Jms Multi Sites.

This module only works on Joomla 1.5 and 1.7.

“Multisites Custom HTML” plugins requires the JMS Multisites version 1.2.70 or higher.

2. Installation

Mutlsites Custom HTML is a zipped file containing the module and the documentation:

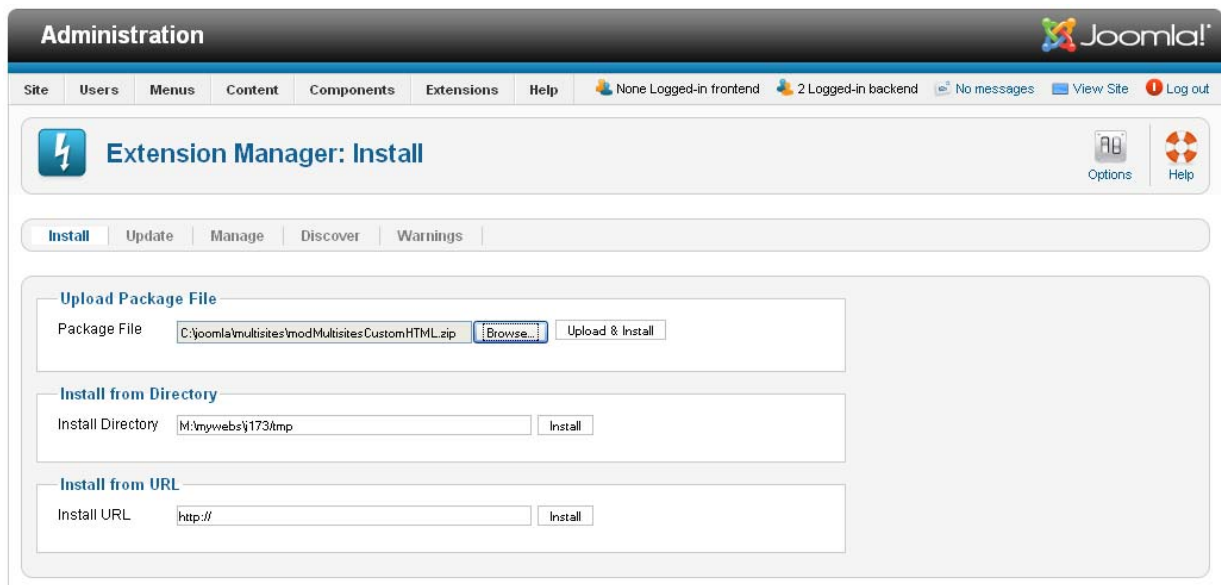
- **modMultisitesCustomHTML.zip** : is the Joomla 1.5 & 1.7 module that allow reading the “Custom HTML” modules defined in other websites and display its content in the current site;

The installation consists in unzipping the “MultisitesCustomHTML_unzip_first_Vx.x.x.zip” into a temporary directory. When unzipped, you have the access to the module and you can it with the standard joomla installation procedure.

2.1. Joomla 1.5 and 1.7 installation

Joomla 1.5 & 1.7 provides a very simple installation interface. The installation consists in selecting the “modMultisitesCustomHTML.zip” file with browse button and after click on the “Upload File and Install” button (as shown below).

The installation must be done on the master website.



This module can be re-installed in each slave site where you want to display “Custom HTML” content coming from other slave site.



The parameters of the modules are very simple:

- “**Site**” that allow select from which website must be read the “Custom HTML”
- “**Custom HTML id**” that allow select the “Custom HTML” to display.
- “**Master Domain URL**” that allow entering the “domain name” that is associated to the master website.

When a “Site ID” corresponds to a slave site, Jms Multi Sites, compute the domain name based on the first domain defined in the slave site.

4. System requirements

The “Multisites Custom HTML” module were developed and tested on Joomla 1.5.25 or joomla 1.7.3

4.1. Joomla 1.5.x and 1.7.x

- MySQL 5.x or higher is required.
- PHP 5.3 or higher is required.
- The Jms Multisites Version 1.2.70 is required.
