Since symbolic link is allowed, BUT gave me a whole bunch of error messages I decided to go with that one. Platform is Unix.

I filled in the site ID and the domain name as I saw it in the tutorial, but when I am done, the message says that I need to make sure the domain is mapped to path/to/joomla/multisites/slave1 (example) Since the tutorial said that both the master and the slave domain needs to be mapped on the same directory, I'm a little bit clueless. By the way, the hello.txt can be accessed from both domains.

Based on the info it seems that you have used the tutorial video CP-03.
So in this scenario, the key element is the setup of the hosting server.
In this case, you have to check that you hosting server have the same "document root" directory for both your master website and your slave site.

If symbolic link is allowed but if you receive error when you deploy the slave site into a specific directory, you have to check the error message and the error may depends on the directory where you have deployed the slave site.
This may depends on the "open_basedir" path define in your website.

So when the "deploy directory" is empty this mean that you have to check the hosting server configuration to ensure that you are using the same directory than your master.

One info I just found out is that the hosting server uses domain aliases. So there's one virtual host which uses the domain names as aliases for the same folder (the joomla folder) on the server.

Could that be a problem?

Oh, and they don't use cname, they use A-records. (whatever that means)

JMS can also work but you will just have some restrictions.

DNS with record A mean Address IP. CName mean alias. In both cases if the result is identical (same IP address) then this is OK to have the alias.

If all the domain are assigned to the same document root (as it seems the case), this just mean that you don't have to fill the JMS deploy directory.

In this case it will more difficult to have specific images folders, templates folders, as all the website will use the same root directory.

In fact you will work like on Windows platform that does not allow the Symbolic Links.

As you could see in the tutorial video 0.b slide 11, DNS server and HTTP Server are different things. You mentioned that you have the DNS server defined with a A record (that mean contain an IP address) and not a CNAME (that means is not defined as a synonym or an alias).

This just mean that you have the IP address assigned to the domain name.

This still does not specify the "document root" or the location on the disk where the domain is assigned.

This is done with your HTTP server adminstration tool.

So DNS server does not seems the problem as you reach a machine with the correct IP address.
